### **CASE UPDATE: Palm Coast Drug Dealer Convicted, Sentenced to 16-Years for Causing Overdose Death**

BUNNELL, Fla. — On March 26, Stephanie Raimundo was convicted and sentenced on multiple charges, including manslaughter, following her January arrest, which resulted from a yearlong investigation by the Flagler County Sheriff's Office Major Case Unit proving that her actions contributed to the overdose death of 22-year-old Calvin Stull in January 2024.

Raimundo pled no contest to Manslaughter, Trafficking in Methamphetamine, Possession of Cocaine with Intent to Sell, and two counts of Trafficking in Fentanyl. Following Raimundo's plea agreement, Judge Dawn Nichols of the Seventh Judicial Circuit found her guilty and sentenced her to 16 years in a Florida Department of Corrections prison, with 449 days of time served.

"This poison peddler is going to prison for manslaughter for selling the fatal dose of poison," said Sheriff Rick Staly. "We investigate every overdose death as a homicide and are committed to holding poison peddlers accountable for their actions. If you are a poison peddler and sell a fatal dose, rest assured that we will come after you. These are very difficult cases, and I commend our Major Case Unit for putting another poison peddler in prison for selling a fatal dose."

# **Palm Coast Drug Dealer Arrested for Manslaughter for Selling Fentanyl Causing Overdose Death**

BUNNELL, Fla. — Following a yearlong investigation, the Flagler County Sheriff's Office Major Case Unit has made an arrest in connection with the overdose death of 22-year-old Calvin Stull, whose body was discovered in Belle Terre Park on January 3, 2024. After the comprehensive investigation, Stephanie Raimundo, 48, of Palm Coast, was arrested on January 8, 2025, for her role in his death.

On the morning of January 3, 2024, the FCSO Communications Center received a 9-1-1 call reporting a male found unresponsive on a park bench under the pavilion at Belle Terre Park. The Palm Coast Fire Department was first on the scene and pronounced the male, identified as Stull, deceased. Deputies identified the victim using photo identification found on his person.

The FCSO Major Case Unit opened an investigation into Stull's death, led by Detective First Class Adam Gossett. With assistance from FCSO's Real Time Crime Center analysts, detectives identified Stull's movements, showing that he had been seen traveling north on Belle Terre Parkway before entering the park on the afternoon of January 2, 2024.

When the medical examiner arrived, baggies containing narcotics were discovered in Stull's pocket. The narcotics were tested and found to be heroin and fentanyl.

The FCSO Special Investigations Unit was notified of the overdose and presence of narcotics and assisted the Major Case Unit to determine the source of the illegal drugs. Through investigative means, they identified Raimundo, a known drug dealer, as the primary suspect. Based on their findings, SIU detectives obtained a search warrant for Raimundo's residence at 77-A Plainview Drive in Palm Coast. In the evening on January 3, 2024, the Major Case Unit, SIU, and SWAT team [served the warrant and uncovered trafficking amounts of various narcotics, including fentanyl, heroin, methamphetamine, cocaine, and marijuana](#). Raimundo and Charles Brockhaus, who also lived at the residence, were arrested and taken to the Sheriff Perry Hall Inmate Detention Facility.

After a yearlong investigation, Major Case detectives obtained an arrest warrant for Raimundo for Manslaughter in connection with Stull's death. On January 8, 2025, the warrant was served at the Sheriff Perry Hall Inmate Detention Facility, where Raimundo was being held without bond. Raimundo now faces 14 charges relating to manslaughter and drug trafficking.

“We are committed to holding poison peddlers accountable who contribute to the ongoing drug problem in our community, especially those who kill someone by selling the fatal dose of poison” said Sheriff Rick Staly. “Thanks to the diligent work of our Major Case Unit, SIU detectives, and Real Time Crime Center analysts, we were able to piece together the events leading to this death and take action against the woman responsible for selling the poison. If you are a drug dealer and kill someone, we will investigate until we can arrest you and put you in jail, no matter how long it takes.”
